## 6. BUSINESS ITEMS AND REPORTS

## 6.1 BC Housing - Supportive Housing Development Application

The Municipal Planner gave a presentation on the development application.

## **Recommendation No.5**

#### Moved/Seconded

That the Accessibility Advisory Committee recommends to Council the approval of the Official Community Plan Amendment application to increase the allowable density on the property to allow a maximum of 40 residential units in a three storey building for non-profit, independent supported, rental housing with the condition that a housing agreement be registered and 4 wheelchair accessible units be provided and the remainder of the units on the ground floor be provided to an adaptable standard.

## **Recommendation No.6**

#### Moved/Seconded

That the Accessibility Advisory Committee recommends to Council the approval of the Zoning Amendment application to create a zone for a 40 unit supportive housing, 3-storey building conditional upon a housing agreement for 100% units be Affordable Housing and 4 wheelchair accessible units be provided and the remainder of the units on the ground floor be provided to an adaptable standard.

# Recommendation No.7

#### Moved/Seconded

That the Accessibility Advisory Committee recommends to Council the partial road closure of Hightide Avenue provided that:

• the building footprint and number of units does not increase in size;

the extended pedestrian walkway improvements are made.

# 6.2 Review of a Typical Adaptable Housing Covenant

In discussion it was noted that:

- In accordance with the Official Community Plan, accessibility/adaptability can be considered as a community amenity at the time of consideration of rezonings.
- A sample accessibility/adaptability covenant was reviewed that had been used, at the time of a rezoning, to guarantee the adaptability of residential housing.

## 6.3 Cowrie Street and Ocean Avenue Pedestrian light;

In discussion it was noted that pedestrian-signaled crossings were needed at this intersection and that the project was identified on the Committee's list of recommended accessibility projects for 2018. A status update was requested by the Committee.

The Municipal Planner will follow up with the Director of Public Works, Parks and Engineering and invite him to update the Committee on the status of the project and the on-street Cowrie Street designated accessible parking space.

## 6.4 SC Highway 101- New pedestrian walkway at Trail Bay Estates;

The Municipal Planner provided the following information:

- A paved walkway along the highway and Trail Bay Estates is being created as a community amenity contribution of the Trail Bay Estates/Clayton Family Lands rezoning application;
- As a result of the Committee's concern for wheelchair and scooter access to the walkway, before paving begins, the Municipal Planner will follow up with the planning file manager to see if the highway access to the walkway can be via a less steep approach at both ends of the walkway to improve access for wheelchairs and scooters.

Small signage on the highway would help identify the walkway route and get people off the highway shoulders.
