Bylaw No. 426-1, 2005

A Bylaw to Set Fees for Sewerage Usage

WHEREAS the *Community Charter* provides that a council may by bylaw impose a fee payable in respect of all or part of a service of the municipality;

AND WHEREAS the Council of the District of Sechelt deems it necessary to amend the fees for sewerage usage;

NOW THEREFORE, the Council of the District of Sechelt, in open meeting assembled, enacts as follows:

1. **TITLE**

This bylaw may be cited for all purposes as “**District of Sechelt Sewer User Fees Bylaw No. 426, 2004, Amendment Bylaw No. 426-1, 2005**”.

2. **PROVISIONS**

Schedule "A" attached to and forming part of Bylaw No. 426, 2004 that sets the Sewer User Rates for those users as outlined therein is deleted in its entirety and replaced with a new Schedule "A", attached to and forming part of this Bylaw.
