## Bylaw No. 426-5, 2009

### A Bylaw to Set Fees for Sewerage Usage

---

**WHEREAS** the *Community Charter* provides that a council may by bylaw impose a fee payable in respect of all or part of a service of the municipality;

**AND WHEREAS** the Council of the District of Sechelt deems it necessary to amend the fees for sewerage usage;

**NOW THEREFORE**, the Council of the District of Sechelt, in open meeting assembled, enacts as follows:

1. **TITLE**

This bylaw may be cited for all purposes as "District of Sechelt Sewer User Fees Bylaw No. 426, 2004, Amendment Bylaw No. 426-5, 2009".

2. **PROVISIONS**




