A bylaw to set fees for sewerage usage

**WHEREAS** the *Community Charter* provides that a council may by bylaw impose a fee payable in respect of all or part of a service of the municipality;

**AND WHEREAS** the Council of the District of Sechelt deems it necessary to amend the fees for sewerage usage,

**NOW THEREFORE**, the Council of the District of Sechelt in open meeting assembled enacts as follows:

**1. TITLE**

This bylaw may be cited for all purposes as "District of Sechelt Sewer User Fees Amendment Bylaw No. 426-9, 2012".

**2. PROVISIONS**




