A bylaw to set fees for sewerage usage

**WHEREAS** the *Community Charter* provides that a council may by bylaw impose a fee payable in respect of all or part of a service of the municipality;

**AND WHEREAS** the Council of the District of Sechelt deems it necessary to amend the fees for sewerage usage.

**NOW THEREFORE**, the Council of the District of Sechelt, in open meeting assembled, enacts as follows:

### Title

1. This bylaw may be cited for all purposes as "District of Sechelt Sewer User Fees Amendment Bylaw No. 426-11, 2014".

2. Schedule A attached to and forming part of Bylaw No. 426, 2004 that establishes the Sewer User Rates is deleted in its entirety and replaced with Schedule A, attached to and forming part of this Bylaw.
