BYLAW NO. 515-4, 2018

A bylaw to amend the Bylaw Notice Enforcement Implementation Bylaw No. 515, 2012

WHEREAS Section 4 of the *Local Government Bylaw Notice Enforcement Act* SBC 2003, c.60 provides that a local government may designate bylaw contraventions which may be dealt with by bylaw notice under the *Act*; and

AND WHEREAS Council of the District of Sechelt deems it desirable to amend its designated bylaw contraventions and penalties regulation;

AND WHEREAS the Council of the District of Sechelt deems it expedient to authorize the use of Bylaw Enforcement Notices for the enforcement of certain bylaws, designate certain bylaw offenses and set certain fine amounts;

NOW THEREFORE the Council of the District of Sechelt, in open meeting assembled, enacts as follows:

1. TITLE

(a) This bylaw may be cited as "District of Sechelt Bylaw Notice Enforcement Implementation Amendment Bylaw No. 515-4, 2018".
